

# Sequoia Union High School District Executive Budget Summary 2023-24 Unaudited Actuals

The Unaudited Actuals report reflects the District's financial activity that occurred during the year, as well as the District's financial position as of June 30, 2024. In addition, the Unaudited Actuals contain supplemental information concerning the District's activity in detail. Education Code requires districts to close their books and adopt the report of financial activities and position by September 15<sup>th</sup> of each year for the preceding fiscal year. This information is submitted to the San Mateo County Office of Education, and the California Department of Education for review.



This Executive Summary Report is divided into the following sections:

- I. **2023-24 Unaudited Actuals**: The Unaudited Actuals reports the financial status for the fiscal year 2023-24, which provides the final revenues, expenditures and fund balance and the balances of the district's one time funds.
- II. **2023-24 Educational Protection Spending Account (EPA)**: Districts are required to disclose the expenditures of the EPA funds as part of the Unaudited Actuals.
- III. Other Funds Student Activity Special Reserve, Charter School Special Revenue Fund, Adult Education, Cafeteria, Deferred Maintenance, Special Reserve Fund for postemployment Benefits, Building, Capital Facilities, County School Facilities, Special Reserve for Capital Outlays and Bond Interest and Redemption Fund.

# I. Unaudited Actuals for 2023-24

The Board's most recent, full discussion on the status of the 2023-24 budget was during the 2024-25 Proposed Budget Report Board item, prior to approval on June 26, 2024. The 2023-24 Unaudited Actuals Ending Fund Balance will be the 2024-25 Beginning Fund Balance. This section reports on the changes that have taken place since the Estimated Actuals.

The Unaudited Actuals show an excess of revenue over expenses of \$8,133,426 resulting in an increase to the ending fund balance of the same amount.

## **Revenue Summary**

**LCFF/Basic Aid** revenue is composed of three separate sources, State Aid, Property Taxes and RDA residual payouts. The \$204,000 increase as compared to the Estimated Actuals is attributed to an increase in property taxes, AB602 SPED revenue and increase in in-lieu property tax payment to charter schools. Overall property tax revenue growth for 23-24 was 5.53%, which represents a 0.53% increase over our budget projection of 5%.

**Federal revenue** increased by \$247,500 due to additional funds in SPED IDEA entitlement.

State revenue decreased by \$664,600.

- Increased lottery funds \$511,856. Final lottery rates higher than May Revise assumptions (\$211U/\$102R vs \$170U/\$67R)
- Prior assessments \$21,206
- Increased SPED mental health funds \$3,077
- Deferrals of \$1,282,256 from categorical programs. The accounting guidance on State funding allows the district to only recognize revenue from dollars that have actually been spent, resulting in a deferral of the remaining funds to be recognized in the subsequent years. Funds not realized will be incorporated as part of First Interim Adjustment.
- Increase STRS on Behalf Contribution \$81,345

## **Local revenue** \$1.25 million increase from Estimated Actuals

- Leases and rentals increased \$245,049
- Interest/Gains on Investments increased \$1,428,847
- Local donations decreased \$834.558
- Services to other districts increased \$412,688

# **Expenditure Summary**

The total for **certificated salaries** is \$92.7M, which represents a final cost of \$244K less than projections at Estimated Actuals.

**Classified salaries** for totaled \$37.3M which represents a \$72K increase from Estimated Actuals.

**Employee benefits** total \$66M, a \$300K decrease from Estimated Actuals. This decrease in benefits represents a direct correlation to the decrease in certificated salaries.

The **supply category** finished the year at \$3.5M less than Estimated Actuals due to unrealized expenditures budgeted restricted resources for a total of \$7M.

**Services and other operating expenses** finished the year at \$3.4M less than Estimated Actuals for a total of \$27M.

- Site Carryover \$144,070
- Unexpended services and other expenses \$267,084

**Other Outgo** increased \$413,861 increase from estimated actuals due to increased county operated services.

## **Fund Balance**

There have been both revenue and expenditure changes since the Estimated Actuals. The Unrestricted Fund Balance is \$41,984,301, an increase of \$6,375,203 from the Estimated Actuals as outlined above. The total available reserve \$34,147,900 or 14.16% of the total General Fund Expenditures and Transfers Out.

# **II. Education Protection Account**

The Education Protection Account (EPA) provides local educational agencies (LEAs) with general purpose state aid funding pursuant to Proposition 30, The Schools and Local Public Safety Protection Act of 2012, approved by the voters on November 6, 2012.

K-14 local agencies have the sole authority to determine how the funds received from the EPA are spent, but with these provisions:

The spending plan must be approved by the governing board during a public meeting. EPA funds cannot be used for the salaries or benefits of administrators or any other administrative costs (as determined through the account code structure).

Each year, the local agency must publish on its website an accounting of how much money was received from the EPA and how the funds were expended.

Further, the annual financial audit includes verification that the EPA funds were used as specified by Proposition 30. If EPA funds are not expended in accordance with the requirements of Proposition 30, civil or criminal penalties could be incurred.

The District received EPA funds in the amount of \$1,612,244 that were spent in the following manner described below:

# **III. Other Funds**

**Fund 08,** The Student Activity Special Revenue Fund is used to report financial activities for Associated Student Body accounts as required by GASB statement 84. Fund was established as of FY2020-2021. Revenues are \$3,000,075 and expenditures are \$2,810,455 with an ending bank balances as of June 30, 2024 of \$2,769,305.

**Fund 09**, The Charter Schools Special Revenue Fund is used to report the East Palo Alto Academy dependent charter school as part of the SUHSD authorizing district but reported outside of the District's General Fund. Revenues are \$6,401,986 and expenditures \$6,752,248. A \$747,920 contribution from the General Fund was required to covers expenses outside of the Charter school operations such as grounds/maintenance, utilities and teachers on sabbatical.

**Fund 11**, The Adult Education Fund is used for the purpose of recording all Adult Education income and expenditures and it is earmarked to support the adult education program throughout the district. Revenues are \$2,814,793 and expenditures are \$2,556,987. The program is supported primarily with state funding with a small amount from federal revenues.

**Fund 13**, The Cafeteria Fund is used for the purpose of recording only income and expenditures related to the operation of the District's Food Services program. Revenues are \$4,055,780 and expenditures \$3,693,462.

**Fund 14**, The Deferred Maintenance Fund is used to record the District's contribution for Deferred Maintenance purposes. Expenditures in this fund are for major repair or replacement of plumbing, heating, roofing, and other items that have been approved by the State Allocation Board (SAB). Revenues are \$75,499 and expenditures \$1,230,731. Redevelopment revenue of \$3,208,255 was transferred in from the restricted General Fund to Fund 14.

**Fund 21**, The Building Fund is used to account for the sale of general obligation bonds from Measure W, approved by the voters in 2022. Bond proceeds are used for construction, remodeling, modernization and infrastructure repairs throughout the district. Revenues including other financing sources are \$80,071,401 and expenditures are \$349,482.

**Fund 25**, The Capital Facilities Fund is used to separate money received from the fees levied upon developers or other agencies as a condition of building or expanding what is called "habitable space." Expenditures from this fund are limited to the expansion or improvement of sites due to enrollment growth. Revenues are \$3,226,721 and expenditures are \$289,312.

**Fund 35**, County School Facilities Fund is established pursuant to Education Code Section 17070.43 to receive apportionments from the 1998 State School Facilities Fund (Proposition 1A), the 2002 State School Facilities Fund (Proposition 47), the 2004 State School Facilities Fund (Proposition 55), the 2006 State School Facilities Fund (Proposition 1D) or the 2016 State School Facilities Fund (Proposition 51). The fund is used primarily to account for new school facility construction, modernization projects, and facility hardship grants, as provided in the Leroy F. Greene School Facilities Act of 1998 (Education Code Section 17070.10 et seq.). Revenues are \$8,302,314 and expenditures are \$13,805,536.

**Fund 40**, The Special Reserve Fund for Capital Outlay is used for capital improvement purposes. Major expenditures over the past several years include portions of the cost for construction and equipment of the new buildings throughout the District and the replacement of copiers for the sites. Revenues are \$1,586,773 from earned interest, rental and advance development contribution from META, and expenditures are \$2,091,239. \$3,208,255 of redevelopment revenue was transferred in from the restricted General Fund.
